





REPORT ON THE COMMUNICATION AND DISSEMINATION ACTIVITIES CARRIED OUT

A) DESCRIPTION OF THE ACTIVITIES

During these first months of the project, various communication and dissemination activities were carried out. In particular, a special website, a Twitter page, a Facebook page and an Instagram page were activated in order to disseminate and publicize the project's activities. It is necessary to emphasize that the project partners decided, as a shared and deliberate strategy, to use these platforms for the sole purpose of publicizing project-related activities and to exclude their over-active use, i.e. not to share third-party web content on them or to use them to participate in web discussions on project topics.

Furthermore, on the level of strengthening internal communication, a special newsletter and a shared drive were created where the units participating in the project can easily exchange information and materials. Namely, the focus groups with the target groups and the first workshop presenting the project. Seven focus groups were held from 27.07.2022 to 29.09.2022, involving subjects and professionals relevant for the project (judges, lawyers, journalists, associations, criminal law scholars, victims of antisemitic incidents). After the calendar of sessions was set and the subjects to be invited were identified, invitation letters were sent to participants containing only general information about the research project, and logisitical information useful for participating to the focus group.

Further scientific dissemination and networking activities have been held by members of the HIDEANDOLA research group:

- Alberto Di Martino and Federica Merenda participated to an online informal seminar discussion on contemporary challenges related to antisemitism with Prof. Uffa Jensen and Prof. Marcus Funck, working at the ZfA at TU Berlin, 21 September 2022.
- Federica Merenda shared part of her research in historical antisemitism and the relative legal response in a presentation titled "Individual Criminal Responsibility to reconciliate ourselves with the reality of international crimes: an outdated paradigm in the era of killer robots? An Arendtian account of AI" at the 3rd Annual Conference of SAFI on "Responsibility", Verona-Bosco Chiesanuova, 29 Settembre 1 Ottobre 2022.















As part of the networking activities, Federica Merenda also participated to the Workshop 'Populism in History and Today', also chairing a Panel, that was organized by and held at TU Berlin, Berlin, 12-16 September 2022.

B) EVALUATIONS AND FURTHER IMPROVEMENTS

For the time being, the pages have met with modest success. This is because they do not yet house the outputs of the research, since it is still in the process of being carried out. For this reason, it will be necessary to implement the activities of the pages in the coming months by enriching it with news of the progressive results achieved. In addition, in the final phase, it will be necessary to set up special discussion spaces (e.g. blogs) on the project topics and an archive in which to collect the research material to be made available to the public.
